And the group has met over these past few months and have recommended essential changes to our Ethics Code. The local laws are still in the process of being drafted and they will be distributed to our Town Board members well in advance of the February 28th Town Board meeting. These resolutions will include numerous amendments to our current Code of Ethics, as well as establish rules for situations where members of the same family are employed by the Town. These significant changes are necessary in order to maintain our transparency and to keep our progress moving forward. So I want to thank our Ethics Working Group, along with our Town Attorney's office for working on this very important initiative. It's basically stay tuned.
