SUPERVISOR BOSWORTH: Good evening. If everybody can please find their seats. Thank you. And now if everyone would please rise for the Pledge.

(Pledge of Allegiance.)

SUPERVISOR BOSWORTH: Thank you. Mr. Wink, if you would please call the meeting to order.

MR. WINK: Town of North Hempstead Board Meeting, Tuesday, May 16th, 2017. Councilwoman De Giorgio.

COUNCILWOMAN DE GIORGIO: Here.

MR. WINK: Councilman Ferrara.

COUNCILMAN FERRARA: Here.

MR. WINK: Councilwoman Kaplan.

COUNCILWOMAN KAPLAN: Here.

MR. WINK: Councilwoman Russell.

COUNCILWOMAN RUSSELL: Here.

MR. WINK: Councilwoman Seeman.

COUNCILWOMAN SEEMAN: Here.

MR. WINK: Councilman Zuckerman.

COUNCILMAN ZUCKERMAN: Here.

MR. WINK: Supervisor Bosworth.

SUPERVISOR BOSWORTH: Here. So following our Town Board procedure, we have our 30 minutes of public comment on any matter not having to do with items that are on the agenda. We do ask that you keep your comments to three minutes. Mr. Wink, if you could call the cards.

MR. WINK: We have two cards.

(Whereupon, the public comment portion of the agenda was off the record.)

(Whereupon, the Town Board meeting agenda resumed.)

SUPERVISOR BOSWORTH: Mr. Wink, if you'd please strike item 33 and begin tonight's agenda.

MR. WINK: Continuations: Item 1, a public hearing to consider the application of Jagjit Singh for a special use permit for the premises located at 3330-3340 Hillside Avenue, New Hyde Park, New York and designated on the Nassau County Land and Tax Map as Section 9, Block 481, Lot 434.

COUNCILMAN ZUCKERMAN: Okay. This proposed action is for the alteration of an existing gasoline service station to provide self service, the reconfiguration of the pump islands, and installation of a steel canopy. It's my understanding that this matter has been submitted to Nassau County Planning but that the -- they have not rendered a decision based on that they're awaiting a traffic study related to curb cuts. Counsel, is that the --

MR. O'BRIEN: Thank you, Mr. Wink, thank you, Councilman Zuckerman. For the applicant, Larry O'Brien, professional engineer, Highpoint Engineering, 521 Conklin Street, Farmingdale, New York. I just want to submit the affidavit of mailings and some copies of the postage.

MR. WINK: Thank you.

COUNCILMAN ZUCKERMAN: Counsel, before you begin, I just wanted to say that because we do not have a decision from Nassau County Planning, it's my recommendation tonight to continue this without a date, to be determined until we have an answer from Nassau County Planning. I don't want to interrupt --

MR. O'BRIEN: No. I know what you were going to say --

COUNCILMAN ZUCKERMAN: Right.

MR. O'BRIEN: Agreed, yes. And I have the applicant, Mr. Jagjit Singh, J-a-g-j-i-t, and the traffic engineer will provide a report and describe the situation for the property.

COUNCILMAN ZUCKERMAN: Okay. Terrific.

MR. O'BRIEN: I have some copies, a small size of what we have on display for you. Thank you, Supervisor Bosworth and members of the board for considering this application for 3330 Hillside Avenue, New Hyde Park, Section 9, Block 481, Lot 434, the northwest corner of Hillside Avenue and Herricks Road. The proposal is for pump island reconfiguration with three self-serve pump islands along Hillside Avenue and one pump island along Herricks Road, combined with a new steel canopy, 24 feet wide by 78 feet long above the three pump islands along Hillside Avenue. I'll just point it out for you. The canopy is above the three pump islands along Hillside Avenue and where this separate pump island along Herricks and the gasoline tank is in the center, the existing building is to the left. Existing curb cuts along Hillside Avenue and Herricks Road.

COUNCILMAN FERRARA: And there's no canopy on the one on Herricks Road?

MR. O'BRIEN: Correct. No canopy at this time on Herricks Road. It's a separate pump island similar to the prior.

COUNCILMAN FERRARA: But I thought the -- the -- one of the purposes of the canopy was the fire retardant efforts, suppresses the fire.

MR. O'BRIEN: Yes. You can have -- which we will have when we get approval from Nassau County Fire Marshal, the fire suppression can exist without the canopy. It will be between the two posts of the light poles. Thanks for pointing that out. Thank you. The canopy is set back five feet from Hillside Avenue right-of-way, which we received a variance from the ZBA from the ten-foot required setback. The existing building shall remain and be utilized for the fueling portions of the gas station. No conversion at this time of any other use. The associated underground storage tanks were previously approved by the board and will be piped to these pump islands as shown here. The four existing curb cuts, two along Herricks Road and two along Hillside Avenue, will remain in the same capacity as they were for the previous service station. And at this time, I'd like to introduce the project's traffic engineer, Frank Filiciotto, of Stonefield Engineering, to provide more details about the driveways and the site access.

MR. FILICIOTTO: Thanks a lot. Good evening, Madam Supervisor, members of the Town Board. For the record, Frank A. Filiciotto, F as in Frank, i-1-i-c-i-o-t-t-o. I'm with the firm

Stonefield Engineering and Design, office is at 2702 41st Avenue in Long Island City. Just for the record, I'm a licensed professional engineer in New York State. I have over 14 years of experience as a traffic and transportation engineer. I have testified in front of this board as a traffic expert in the past, as well as multiple boards throughout Long Island as a traffic expert. So thank you for the opportunity to speak on the application this evening. I do have with me the traffic study that Larry mentioned, if I may submit it to the board. There are nine copies there and they are dated May 16th, 2017. Obviously, the board will need some time to review it but I can provide a synopsis for you this evening. This has not yet been submitted to Nassau County Planning Commission but it will be done tomorrow. We wanted you to get it first being that we had the hearing tonight. And thank you for hearing us tonight even though that that matter has not been buttoned up. But we do believe that this study will address their comments. Mr. O'Brien alluded to some of the components of this development that were in front of you for this evening. This site has historically operated as a gas station. At one time it had six-vehicle fueling positions on it. What we're proposing is eight-vehicle fueling positions; three underneath the canopy, one exposed. So when you look at the history of this site, you know, it's a modest increase in development when you look at it. There's no C store being proposed, no auto repair being proposed. It's strictly a gasoline station by -- by, you know, the true -- true meaning of the word. In terms of access, and I think that's what everyone is most concerned with. There are four curb cuts. There are two curb cuts along Herricks Road and two curb cuts along Hillside Avenue. Currently, right now there's no control. You can make lefts in, lefts out, right in, right out everywhere. In our traffic study we performed counts on April 19th during the morning and evening peak hours. They're typically the hours that we looked at for gas station because they enter on the roadway of peak hours going to work, people running errands, that typically happens in the morning between seven and nine and in the evening from four to seven. So we looked at traffic very closely during those times and it was really no surprise to us that the traffic on Herricks Road builds back from the intersection at Hillside to the extent that it makes left turns very difficult to occur. So what we're proposing to do on Herricks Road is limit the northerly driveway to right-in. right-out and the southerly driveway to right-out only. Basically, remove any ability for left turns to occur there. Obviously, Herricks Road is a County road and we need to go, not only through the Planning Commission process but, also, through 239F and engineering review. What they've typically been requiring as of late are no left turn signs on either driveway to restrict those movements. On Hillside Avenue, again, two -- two driveways but all in control. We do right now at the site left turns, right turns, everything. What we propose to do is make this curb cut, the easterly most one a right-in only driveway so that you can access the pumps on the east side of the site. And in then this driveway would remain full access because it's far enough away from the intersection and there is the opportunity with good sight distance to make those left turns and there's also, it's not shown here, but there is a left-turn lane that extends back from the intersection for vehicles to queue and make that turn. Now our burden there is that Hillside Avenue is a DOT roadway. So we've submitted to DOT already and we've gotten some preliminary feedback. But you know how DOT is. It's a long process.

SUPERVISOR BOSWORTH: We do know.

MR. FILICIOTTO: So that's our burden. Obviously, we need to get their approval as well. All in all, when we looked at the traffic associated with this site, the increase from what used to be to what is proposed to be, you're looking at about 33 new vehicles coming to this site in the peak hour. Now just to give you an idea at what's at that intersection now, in the peak hours in the morning, over 3,300 vehicles enter that intersection in the morning and over 4,300 enter it in the evening peak hour. So you're only at magnitude of about one percent of the traffic that goes through that intersection, which is pretty imperceptible. Most of the traffic associated with a gas station is pass-by traffic, it's traffic that's already on the road. It looks at the price, I need gas. Pulls in and then continues on the original path of travel. That traffic really isn't new, it's already there today. It's just passing by because the site's inactive. We think with the access consolidation there's the benefit of reduced conflict points, obviously without the ability to make left turns on Herricks Road, you have a much cleaner site access point with right-in and right-out. Similarly on Hillside Avenue, you could reduce the ability --

COUNCILMAN FERRARA: But you don't have it on Hillside Avenue because you're proposing a left turn.

MR. FILICIOTTO: We are.

COUNCILMAN FERRARA: And that is right after the median with the flowers and everything and two turn lanes there.

MR. FILICIOTTO: Correct.

COUNCILMAN FERRARA: So for people to make a left turn into a turn lane, I think is not a satisfactory maneuver because you're going to be causing people to try and come out there, if those turn lanes are backed up, they could be encroaching on the traffic going the other way. I'm not so sure that that is a good plan.

MR. FILICIOTTO: We did a gap study and that gap study essentially looked at the spacing between cars on Hillside Avenue. Hillside Avenue being the major of the two roadways, I know Herricks is also a very busy roadway. Hillside is busier. It gets the majority of the green light when you're driving through the intersection. So traffic moves a little bit more efficiently along Hillside than it does along Herricks by virtue of that. There are opportunities to make a left out. I agree with you, it's a difficult movement.

COUNCILMAN FERRARA: I live near there. I think it's an extremely difficult movement. Well, we put stop lights a block further down because of the number of accidents there because people are trying to make a turn onto Hillside Avenue heading east and there were quite a few accidents and a couple of fatalities. That's what precipitated having a traffic light there. I do not believe that that's a good move to put a left-turn lane onto Hillside Avenue because you have those two lanes that are turn lanes onto Herricks Road.

MR. FILICIOTTO: Right. Understood and your point is more than well taken. We certainly have the burden of the DOT approving that through the DOT.

SUPERVISOR BOSWORTH: I'm just going to interrupt for a second.

MR. FILICIOTTO: Sure.

SUPERVISOR BOSWORTH: What would your suggestion be?

COUNCILMAN FERRARA: No left turn out of there. Because I think that just endangers people's lives as they're trying to make a left turn into a turn lane and then if they try to get out and they get caught that they can't make that turn, they're stuck in the middle of Hillside Avenue obstructing traffic or put in a dangerous situation. So, I mean, I lived there for 40 years and it's not something I would recommend.

COUNCILMAN ZUCKERMAN: Outside of the no left turn onto Hillside, the other curb cuts --

COUNCILMAN FERRARA: They're fine.

COUNCILMAN ZUCKERMAN: Okay.

MR. FILICIOTTO: Thank you for the comment. We're conferring right now with --

COUNCILWOMAN KAPLAN: Is that currently they can make that left turn?

MR. FILICIOTTO: No. The site's inactive but if you were to turn the switch on, there's no turn prohibitions anywhere. So legally you could make the left turn. There's no left turn sign there now.

COUNCILMAN FERRARA: But it's been like everybody knows you don't.

MR. FILICIOTTO: Right. It self regulates. I think that's what, you know, I am understanding. You know, if you're there for an inordinate amount of time, you're probably just going to give up and make the right turn. It kind of self regulates. It kind of hinges off that convenience effect where you purchase gas because it's convenient and if you can't make the left at 4:00 or 5:00 because it's too busy, you probably won't do it. But your point, like I said, is very well taken.

MR. O'BRIEN: And we ---

MR. FILICIOTTO: Larry was able to confer with Mr. Singh during that dialogue and he's fine relinquishing the left turn out. So we would approach the State with that already in -- in place.

SUPERVISOR BOSWORTH: But, you know, and that's the point, you know, of hearings but especially how valuable it is to have somebody who's lived in the area and, you know, theoretically things can work but if you live there, you know what --

MR. FILICIOTTO: True.

SUPERVISOR BOSWORTH: — you know what the everyday reality is.

MR. FILICIOTTO: Agreed. So —

SUPERVISOR BOSWORTH: That's great.

MR. FILICIOTTO: — that sums up essentially the high level view of the traffic study. I don't want to bore you by getting into too many details, unless the board would like me to. But obviously we need to get through Nassau County Planning Commission. We'll make that change before that report is submitted. Just understand, the report you have does assume the left turns out onto Hillside. So that would be a minor change, a minor benefit really, I think, in your eyes and in our eyes too. So that being said, if the board has any questions, I'd be happy to answer them.

MR. ZUCKERMAN: Commissioner Levine, could you speak to this site and what's going on with Nassau County at the site in particular?

MR. LEVINE: Good evening. So the concerns that the Planning Department raised is the same ones that we've been discussing. The possible consolidation of the two curb cuts on -- on the County Road, on Herricks, or just the outright elimination of the southern most one and then concern with the double curb cuts on Hillside, reactivating those. It's actually very common that when we approve something on Jericho or Hillside, that this board will follow up with an ordinance prohibiting left turns. So as is standard procedure as our concerns with the two agencies having jurisdiction, the New York State DOT and Nassau County Public Works and the County Planning Commission suspended their review of what's called the 239F — I'm sorry, 239M referral. Now what happens is the Town Board actually can't act until they've issued an advisory

opinion or until, you know, 30 days has lapsed. So we were not at all surprised to --to hear the same comments coming back and we've been in coordination with them. We just received the traffic study this afternoon. The -- Nassau County will get it tomorrow. We'll compare notes next week. But what I predict will happen is the State will approve the curb cuts on Hillside contingent on left turn prohibition. I don't know yet what County DPW is going to do with the ones on Herricks. And then as soon as we know, we'll incorporate that into our recommendation to the board.
